

How to search for documents submitted to the SEC by public, American companies:

- 1) Go to [EDGAR](http://www.sec.gov/edgar.shtml) on the open web (free and open to all; access doesn't have to be paid for by the UofC; no sign-in required).
- 2) If you want, check-out the Quick EDGAR Tutorial, About EDGAR, and the Descriptions of SEC Forms. To search the filings, go to **SEARCH FOR COMPANY FILINGS**.



3) Select **COMPANIES & OTHER FILERS**.

- 5) You will get a long list of every form that had to be filed with the SEC since 1994 (if the company has been around and public that long). To weed this down a little, enter a form type. I'm looking for a 10-K (Annual Report), but you can look for a 10-Q (Quarterly Report), and 8-K (proxy, prospectus, communication, current report filing). Also, look for these numbers, followed by /A, as this is an amendment.
