To be held in Calgary, this one day Forum will feature speakers focusing on the unique aspects of electricity deregulation in Alberta. Topics discussed will include: Stranded Costs, Investment in New Generation, Retail Competition, Transmission Issues, Strategies & Opportunities. An additional perspective will be brought by speakers from California. In 1998, California became the first U.S. state to move into full scale electricity deregulation. We are pleased to announce that Dr. William Shaw, Professor in the Department of Mechanical Engineering, has been awarded the Institute's 1998 Resident Fellowship. The Fellowship buys out teaching time to allow the recipient the opportunity to complete a research project. The subject of Dr. Shaw's work is fundamental and applied research on *Hydrogen Embrittlement of Steel*, affecting pipelines and other pressure vessels. His work will be completed in early 1999 and will be published by the Institute.

The 1998 Killam Fellowship, awarded through the University of Calgary, has been

Chairman of the Global Crossroads Initiative, gave the opening re-

marks at the kick-off breakfast for National Transportation Week in Edmonton, May 29, 1998. Mr. Daniel will also be making a presentation before the provincial Deputy Ministers of Transport at the Transportation Association of Canada's annual conference in Regina in September 1998. Following this, an opportunity to speak before the provincial Transport Ministers is being arranged.

A speaker series recently concluded on the theme of "Calgary as a Transportation Hub," coorganized with the Calgary Transportation Authority and the Calgary Chamber of Commerce. The following summary provides highlights from each of the speeches:

Lamar Durrett, President & CEO, Air Canada

Mr. Durrett commented on the future of Calgary's air services. He stated that it is dependent on three major factors: the economy, airline alliances and air policy. As economic activity continues to grow in Calgary, Air Canada will add new services to complement this economic activity. Currently, 1,000 Air Canada and AirBC employees live and work in Calgary. The airline world is being dramatically changed by a new generation of airline alliances. Calgary finds itself linked to two such large alliance groups through Canadian Airlines and Air Canada. Air Canada's Star Alliance is a partnership with Lufthansa, United Airlines, SAS, THAI, VARIG, Ansett Australia and Air New Zealand airlines offering a network of more than 660 destinations on six continents. The third major factor influencing the future of Calgary's air services is the role of government in creating and implementing air policy. Mr. Durrett acknowledged that the Canada - U.S. Open Skies Agreement played a big part in Air Canada's financial turnaroud. He indicated that he is very supportive of a free-market approach to international services, with phase-in provisions and an opportunity for all carriers to prosper.

Darshan Kailly, President & CEO, Canadian Freightways

Mr. Kailly challenged the audience to consider Calgary - Population 17 million. He explained that in today's reality, putting goods on a multi-product truck in Calgary today, by 9 a.m. tomorrow those goods can reach about 17 million people. He then provided some statistics on the importance of trucking to Canada's economy. In 1996, Canada's total world-wide trade was over \$500 billion and trucks carried 55% of that trade. The Canada-U.S. border is a major route for trade by truck with one truck crossing the border every three seconds. Every hour trucks carry \$30 million in goods across the border. Trucking is also big business in Calgary with over 35,000 trucks per day moving in and out of the city. Mr. Kailly then spoke about three key trends in his industry — one

the need for speed of delivery, two the need for time certainty on delivery, and three the focus on core competencies rather than expending resources on functions that do not add value.

Hugh MacDiarmid, Executive Vice President Commercial, Canadian Pacific Railway

Mr. MacDiarmid began by discussing transportation trends such as: globalization, north-south trade, industry concentration, information technology and logistics management. These trends require high asset utilization and access to capital. He then spoke about policy choices that affect his industry, such as the increasing use of trucks for freight, the higher rail taxation levels in Canada relative to the U.S., rail network rationalization and the consolidation of the grain distribution system towards fewer higher through-

put elevators. He concluded by predicting a bright future for

Calgary as a western transportation hub thanks to the Alberta

Advantage: a robust economy, new investments in transportation infrastructure, and a solid resource base.

Mike Sprague, President, Tibbett & Britten Group North America

Tibbett & Britten Group is a leading specialist distribution group, operating in 22 countries, employing 27,000 people, and handling US\$75 billion worth of clients' goods annually. Mr. Sprague outlined what is changing in distribution: the continen-

talization of manufacturing through free trade, competitive pressures driving efficiency, inventory being reduced with just-in time methods, and fewer key distribution hubs becoming the norm. He explained that Canada can be serviced by two hubs, one in Calgary and one in Toronto providing daily coverage to 90% of the country. Calgary has an excellent future as a distribution hub, but he advised to watch real estate costs, and that the major opportunity for Calgary would be to capture east-bound traffic flows.

A Conference on "Telecommunications Regulation and Deregulation: The New Frontier" was held in Calgary on April 28-29,
