

# Canadian Gambling Digest 2003-2004: Addendum

The present document contains the following updates to the 2003-2004 *Canadian Gambling Digest* (Canadian Partnership for Responsible Gambling, 2006):

**Page 2:** Table 1

In Nova Scotia, there were 0 *Bingo Facilities*.

**Page 5:** Table 8

In Alberta, *Total Revenues* were \$291,495,000 (not \$296,013,000). Across the country overall, *Total Revenues* were \$1,106,626,280 (not \$1,111,144,280).

**Page 6:** Table 9

In British Columbia, *Total Horse Racing (Tax) Revenues* were \$1,878,000 (not \$8,555,113), and *Total Revenues* were \$729,521,000 (not \$736,198,113). In Saskatchewan, *Total Ticket Lottery Revenues* were \$12,347,715 (not \$41,513,791) and *Total Revenues* were \$279,671,165 (not \$308,837,241). In Nova Scotia, *Slot Revenues* were \$30,690,862 (not \$5,942,877) and *EGM Revenues* were \$148,778,862 (not \$124,030,877). Across the country overall, *Total Revenues* were \$6,261,041,762 (not \$6,296,884,952).

**Page 6:** Table 10

In British Columbia, *Total Gaming Revenues to Government* in 02/03 were \$672,815,000 (not \$685,424,370); in 03/04, revenues were \$729,521,000 (not \$736,198,113). The % change was +8.4 (not +7.4). In Saskatchewan, *Total Gaming Revenues to Government* in 02/03 were \$247,514,663 (not \$278,415,398); in 03/04, revenues were \$279,671,165 (not \$308,837,241). The % change was +13.0 (not +10.9).

**Page 7:** Chart 2

In British Columbia, the *Percentage of Government Revenue Derived from Gaming* in 03-04 was 2.7 (not 2.8). In Saskatchewan, the *Percentage* in 02-03 was 5.1 (not 5.7) and in 03-04 was 5.5 (not 6.1).

**Page 7:** Table 11

In Alberta, *Total Revenues* in 03-04 were \$128,063,000 (not \$225,982,000); in 02-03, revenues were \$125,418,000 (not \$205,752,000). Across the country overall, *Total Revenues* in 03-04 were \$569,714,798 (not \$667,633,798).

**Page 8:** Table 12

In Saskatchewan, *Distributions to Charity* were \$37,883,499 (not \$17,020,000). In Nova Scotia, *Distributions to Charity* were \$235,000 (not \$35,000). In New Brunswick, distributions to *Responsible Gambling Initiatives* were \$32,042 (not \$117,149). In Prince Edward Island, distributions to *Responsible Gambling Initiatives* were \$5,440 (not \$63,895). In Newfoundland and Labrador, distributions to *Responsible Gambling Initiatives* were \$32,281 (not \$108,737).

**Page 9:** Chart 3

In British Columbia, the *Percentage of Government Gaming Revenue Spent on Problem Gambling* was 0.55 (not 0.54). In Saskatchewan, the *Percentage* was 1.43 (not 1.30), while in Nova Scotia, the *Percentage* was 2.91 (not 2.89). Across the country overall, the average *Percentage of Government Gaming Revenue Spent on Problem Gambling* was 1.02 (not 0.99).

**Page 12:** Table 18

In Saskatchewan, the number of *Total Clients* was unavailable (not 805).
