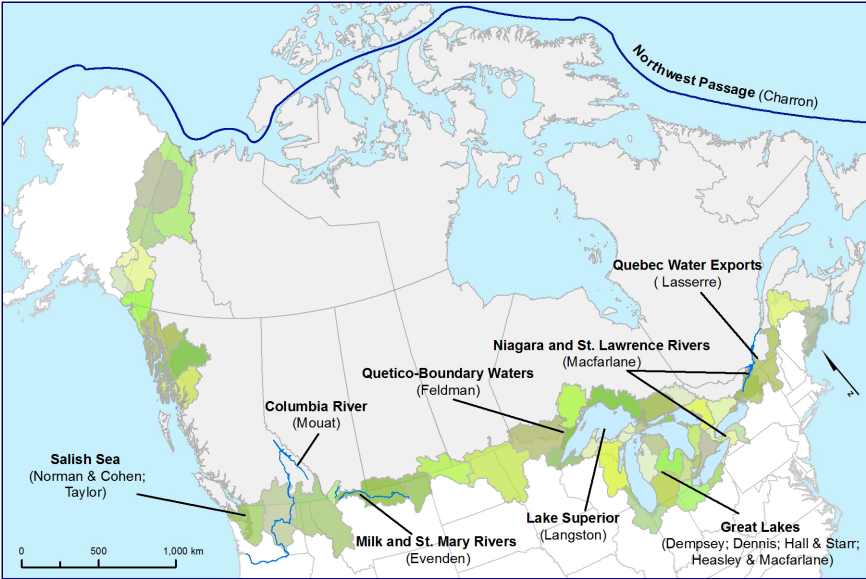
Canadian Studies at Carleton University, and the Canadian Studies Program at Michigan State University.
