The Institute's 17th Annual Conference "Current Issues in Gambling Research" took place at The Banff Centre, April 12-14. More than 100 conference attendees heard presentations from a range of established and up-and-coming gambling researchers from jurisdictions around the world. The conference poster presentation session included 39 high-quality research posters. Winner of the award for best poster went to Kristy R. Kowatch from Lakehead University for her poster entitled, "Review of Gambling Behaviours in Indigenous Populations within Canada."

At the conference welcome reception, two Albertan researchers were honoured for their remarkable contributions to gambling research. Institute Research Director, Dr. Nady el-Guebaly, was recognized for being appointed as a Member of the Order of Canada for distinguished leadership on addictions research and treatment (see Fall 2017 newsletter for details). Dr. Garry Smith was recognized for his longstanding contributions to gambling research in Alberta and his foundational contributions to the establishment of the Institute.

The primary aim of the Alberta Gambling Research Institute, a consortium of the Universities of Alberta, Calgary, and Lethbridge, is to support academic research related to gambling.

Dr. Garry Smith Recognized at Conference for His Outstanding Contributions to Gambling Research

Gambling Research Specialist Dr. Garry Smith was recognized at the Institute Conference 2018 for his outstanding contributions to gambling research in Alberta. Dr. Smith was one of the first Canadian academics to pursue scholarly gambling research and his pioneering, policy-relevant investigations proved pivotal for the establishment of the Institute in 1999. Smith was also the Institute's first appointee as Gambling Research Coordinator at the U. of Alberta and held the position from 2000 until 2018. In this role, Smith was a trusted mentor to multiple generations of Albertan gambling scholars and graduate students. Additionally, throughout his time with the Institute, he garnered a reputation as a highly respected scholar who relished tackling the thorny issues surrounding gambling – in particular, the provincial governments' somewhat conflicted role as both gaming operator and regulator.



Smith's voluminous body of gambling research has included investigations on an extensive array of topics such as gambling prevalence in Alberta, Video Lottery Terminals (VLTs), Responsible Gambling Frameworks, The Reno Model, sports betting, criminal involvement, problem gambling, casino tourism, and issues pertaining to the legalization of gambling in Canada. He frequently appeared as an expert witness at gambling-related trials across the country and is considered one of Canada's foremost academics on the subject of gambling legalization. In addition, he served as the Institute's official spokesperson in the national media and his interviews were featured on CBC television's

The National, Newsday, The Fifth Estate, and several sports-betting documentaries.

Dr. Garry Smith, Professor Emeritus, retired from his position as Gambling Research Coordinator at the University of Alberta at the end of March 2018.

From the Archives...Legendary Alberta Golden Bears Sportsman Garry Smith

Those who have spent time getting to know Garry Smith soon discover that when he's not pursuing gambling research, he's likely to be found playing a round of golf, game of basketball, or enjoying a work out. What people may not know is that, in addition to being a leading Albertan gambling researcher, Garry also reached the pinnacle of athletic achievement as a student athlete, coach, professor, and athletic director.

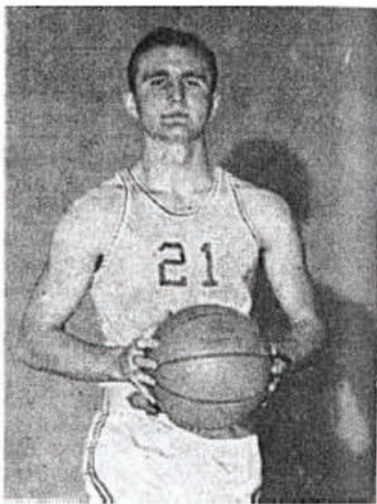

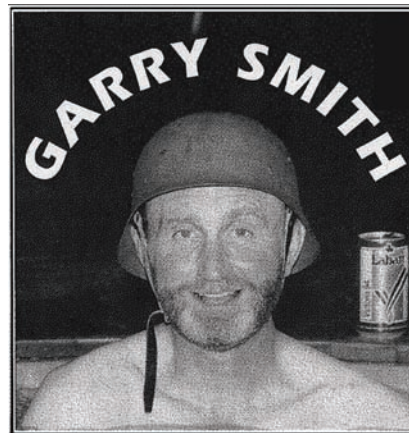
During his four years as an undergraduate student at the U. of Alberta, Garry was a star quarterback for the men's football team and captain of the men's basketball team. His athletic and leadership qualities were formally recognized when he was awarded the Wilson Challenge Trophy of 1962-63 for Most Outstanding Male Athlete at the University of Alberta. As quarterback for the football team, Garry led the Golden Bears to several championship seasons and established a Canadian university record for passing completion percentage that remained unbroken for 45 years. Upon graduation he was drafted by the Edmonton Eskimos but Garry passed up professional football to take graduate study at the University of Western Ontario.

After stops in Ontario and New Brunswick, Garry returned home to Edmonton and obtained his Doctor of Physical Education from the U. of Alberta where his primary research interest related to the sociology of sports. He joined the Faculty of Physical Education and Recreation several years later and went on to enjoy a long and distinguished academic career (1972-1997). His numerous accomplishments included becoming Chair of the Department (1981-1985), Head Coach of the Men's Basketball team (1976-79), Assistant Coach of the Men's Football team (1971-1975), and University Athletic Director.

“Professor Garry Smith deserves to be recognized as a sociologist of gambling in the grand tradition of Erving Goffman. His body of work provides an important balance to research narrowly focused on the prevalence and etiology of pathological gambling. He adopts a long and a wide view of gambling, addressing its cultural histories in Alberta, its social transformations as well as its connection with different kinds of criminal activities in Canada.

Smith is also one of the rare scholars to seriously attend to positive benefits of gambling, exploring the skills and modes of social interaction that can make it a “salutary” activity for many. An early article published in the very first issue of *International Gambling Studies* considered the self-regulatory practice of wagering among recreational golf players. His most recent research, with Linda Hancock, explores a very different gambling context, pointing to the limitations of individual responsibility and the conflicts involved in corporate self-regulation in an era of high intensity, digital gambling technologies. The heated debate recently sparked by their article “Critiquing the Reno model” in the *International Journal of Mental Health and Addiction* testifies to the enduring impact of Smith’s work and its capacity to inspire a rising generation of critical gambling scholars.”
