

Canadian Gambling Digest 2005-2006: Addendum

The present document contains the following updates to the *2005-2006 Canadian Gambling Digest*:

Page 4: Table 3

In Alberta, the number of *Bingo* licenses issued was 1,262 (not 2,262), while the *Total* number of licenses issued was 4,721 (not 5,721). Across the country overall, the *Total* number of charitable gaming licenses issued was 28,262 (not 29,262).

In Manitoba, there were zero licenses issued in the *Casino* category (not 11), and 11 licenses issued in the *Other* category (not zero). The revenues in these categories for Manitoba in Table 7, as well as Table 10, should similarly be reversed.

Page 6: Table 5

In British Columbia, *Internet Lottery* revenue was \$2,400,000 (not \$2,400); *Total Ticket Lottery* revenue was \$439,497,600 (not \$437,100,000); and *Total* revenue was \$1,621,631,700 (not \$1,619,234,100). Across the country overall, *Total Government-operated Gaming Revenue* was \$13,280,971,940 (not \$13,278,574,340).

Page 7: Chart 1

In British Columbia, *Total Government-operated Gaming Revenue* per person 18+ was \$478 (not \$477).

Page 11: Table 8

In Nova Scotia, revenue from *Slots* was \$36,491,597 (not \$67,791,643), while *Total EGM Revenue* was \$153,883,597 (not \$185,183,643). In British Columbia, *Total Revenue* was \$922,697,000 (not \$924,618,000). Across the country overall *Total Net Gaming Revenue to Government* was \$6,824,106,421 (not \$6,826,027,421).

Page 12: Table 9

In British Columbia, *Net Gaming Revenue to Government* in 2005-06 was \$922,697,000 (not \$924,618,000). This was an increase of 12.7% (not 12.9%) over the previous year. Across the country, the *Overall change* in revenue from 2004-05 to 2005-06 was +5.5% (not +5.6%).

Page 13: Table 10

In Alberta, *Net Gaming Revenue to Charitable Organizations* from their *Casino* operations was \$51,399,000 (not \$172,021,000), while *Total Revenue* to charitable organizations for the province was \$136,189,637 (not \$256,811,637). For the country overall, *Total Revenue* to charitable organizations was \$558,216,262 (not \$678,838,262).

Page 14: Table 12

In Nova Scotia, the *Problem Gambling (Health)* distribution to *Research* was \$1,059,289 (not \$140,367), while the *Total Problem Gambling (Health)* distribution for the province was \$6,676,611 (not \$5,757,689). For the country overall, *Total Problem Gambling (Health) Distributions* were \$83,939,614 (not \$83,020,692).

Page 15: Chart 5

In Nova Scotia, the *Percentage of Government Gaming Revenue* distributed to problem gambling was 3.6 (not 3.1).

Page 16: Chart 6

In Nova Scotia, the *Amount of Government Gaming Revenue* distributed to problem gambling per person 18+ was \$8.92 (not \$7.69). For the country overall, the average was \$3.44 (not \$3.31).

Page 20: Table 18

The *Total* number of helpline calls across Canada was at least 51,084 (not 49,574).
