
The Two Cultures




Figure 3: Academic disciplines of primary literature research publications on gambling, according to journal self-description (N=1292)




What are CGS?

"We embrace the provisional and context-specific knowledge that emerges when distinct and overlapping disciplines begin to converge on new research problems, and we defend its value even when states, policymakers, and industry are unable to discern immediate relevance or utility" (Nicoll, F., Bedford, K., Rintoul, A., Livingstone, C., & Casey, E. The Adverse Effects of Interventions to Reduce Gambling Harm: widening the disciplinary lens.

- Ineffective interventions, and potentially harmful consequences of interventions.
- Histories and current realities of differentiated access restrictions.
- "The ideological tension between 'freedom to gamble ' and 'freedom from gambling' in liberal political debates has very real implications for different populations....We need to attend to the role of gambling in making specific populations the target of punitive welfare policies which involve more or less direct exercise of force through surveillance and policing functions of the state" (Nicoll 2019, 16).

Wider implications?

- How do we comprehensively and robustly measure the unintended effects of proposed regulatory changes, including the 'intervention-generated inequalities,' and the opportunity costs of pursuing one pathway versus others?
- Need for a comprehensive, historically aware, socio-legal approach to public health measures designed to reduce gambling harm.
- Troubling state/industry/academic faith in algorithmic regulation as a solution to harm, via science and technology studies/law and regulation studies/critical data science.
- Risks of intensified surveillance of 'the vulnerable' as a solution to harm, and benefits to the gambling industry.
- Broader critiques of gambling (and alcohol) control approaches that rest on differentiated access for groups of adults: philosophical, historical, sociological, political economic, from critical race and Indigenous studies.
