Institute Conference 2019: Blurred Lines in Gambling Research





The Alberta Gambling Research Institute's 18th Annual Conference will be held March 28 - 30, 2019, at The Banff Centre in Banff, Alberta. Presentations will explore the blurring of gaming and gambling; the blurring of the focus on harms versus addiction; the blurring of treatment, harm reduction, and prevention; and the blurring of traditional face-to-face treatment and self-directed online interventions. Sessions will be relevant to researchers, treatment providers, policy makers, and industry staff.

In the gambling field there has been an incredible paradigm shift! For decades, it was clear what the product was, what was considered problem and pathological gambling, and what prevention and treatment entailed. Those lines are getting fuzzier and fuzzier. When does a video game become a form of gambling? How do we reconcile that most of the gambling-related harm is experienced by those we categorize as 'low risk'? Are the responsible gambling interventions we offer to online gambling patrons, treatment or prevention? This year's AGRI Conference provides the opportunity to discuss these issues among the field's leading researchers.

The primary aim of the Alberta Gambling Research Institute, a consortium of the Universities of Alberta, Calgary, and Lethbridge, is to support academic research related to gambling.



Gambling Research - "Getting the Word Out"

Dr. Fiona Nicoll, the Institute Chair in Gambling Policy Studies at the University of Alberta, hosted two gambling research presentations in September and November. Professor Nerilee Hing came to visit the University of Alberta presenting recent research on the effects of gambling advertising in Australian markets and to share the results of a survey on safe gambling behaviours among Albertan consumers with stakeholders from Alberta Health Services, AGLC, and GameSense.

Professor Tim Simpson also visited from the University of Macau to deliver a fascinating research presentation on the role of electronic baccarat machines in cultivating new, cosmopolitan, 'postsocialist' Chinese citizens.

In addition, Dr. Nicoll and Dr. Mark R. Johnson, a post-doctoral fellow at the University of Alberta. visited Nishhawbe Aski Nations in Northern Ontario on November 16, at the invitation of Indige-Spheres to Empowerment and Pelican Falls First Nation High School. They delivered workshops on the effects of gambling and video-gaming. 

Development of an Ecologically Valid Non-Human Primate Model of Gambling

This project addresses the need for more ecologically valid animal models of human gambling. Our unique non-human primate model will closely mirror the conditions under which risk-sensitive decisions are made by human gamblers and potentially validate existing animal research in this area.

Lottery Winnings and Entrepreneurship

A large academic literature has examined the positive and negative impacts of lottery wins. This research project aims to exploit newly available data from Statistics Canada, as well as data on Canadian lottery winners, to examine the impact of lottery wins on entrepreneurial activity. Our aim is to provide evidence on two contradictory hypotheses; whether the lottery win allows for the financing of new, previously financially constrained, businesses, or alternatively, whether the lottery win encourages existing business owners to exit their business, and pursue greater leisure.

This project brings together international expertise from multiple disciplines (psychology and psychiatry) to advance our understanding and establish a research program on the etiology and treatment of gambling and other addictive disorders from a transdiagnostic and cultural perspective.
