#### **UPCOMING EVENTS**

The **Centre for Regulatory Affairs** is planning a number of events this spring. On April 28th, a one-day seminar will be held in Calgary on *The New World in Gas Transmission: Regulatory Reform and Excess Capacity*. Speakers will address topics such as: recent regulatory and competitive developments in gas transmission in Canada and the U.S.; regulation versus competition - market power; competing visions for the future - the viewpoint of industry; understanding the implications of competition - toll structures and service offerings, secondary markets and capacity/entry issues.

A *Regulatory Economics* course was offered in Edmonton in November and will be repeated again this spring in Calgary. This course is targeted towards individuals without formal training in regulatory economics, but who would benefit from a general introduction to the main concepts, theories, and practice of economic regulation. Stay tuned for additional announcements on events that will be offered on topics such as electricity deregulation, local gas distribution and competition in Alberta, and witness preparation for regulatory hearings.

The Centre for Transportation is continuing to offer the course, *Physical Distribution & Logistics* during the winter 1999 term. This course is offered in partnership with the Canadian Institute of Traffic and Transportation, and is one of CITT's core courses towards its transportation designation. *Executive Strategies for Transportation Projects* is also offered this winter 1999 term; targeted at executives and managers. Participants work in groups to determine the best transportation practices using the case study method.

A one-week block course was held the first week in January on *Decision Support Systems and Environmental Planning in the Transportation and Related Sectors*. Taught by Dr. Bryan Massam, Professor at York University, the course was highly successful, and will be offered again in 1999. Some examples of projects done by students in the class include: sour gas well site selection, finding the best location for an airport, transportation solutions for Southwest Calgary, alternative sites for construction of a railway siding, and a core access improvement project for Canmore, Alberta.

Another course under development for spring is *Process-Based Modeling in Trans- portation*, featuring a Systems Dynamics (SD) modeling approach to transportation issues. SD modeling involves capturing the underlying variables, interactions and patterns of feedback, which results in the behaviour of transportation systems, is-

sues and problems. The power of this approach is in its flexibility to represent the entire life cycle of problems, as well as to integrate management, operational, financial and risk variables.
