The following are updates to the 2010-11 *Canadian Gambling Digest*:

Page 5: Table 6. Charitable Gaming Licences

Saskatchewan: Number of bingo licences was 528. *Total Licences 2010-11* was 3,606.

Canada: *Total Licences 2010-11* was 41,283.

Page 10: Table 11. Net Gaming Revenue to Government

Quebec: *Total Bingo Revenue* was -\$777,000. *Other/Total Lottery Ticket Revenue* was \$473,407,000. *Total Revenue 2010-11* was \$1,349,856,000.

Prince Edward Island: *Total Casino Revenue* and *Slots at Casinos* revenue should have been reported as unavailable (and thus *Total Revenue 2010-11* should have been reported as unavailable).

Canada: *Total revenue 2010-11* was \$7,143,941,000.

Page 12: Table 12. Net Gaming Revenue to Charitable Organizations

Prince Edward Island: *Break Open / Pull-ticket* revenue should have been reported as unavailable.

Canada: *Total Revenue 2010-11* was at least \$453,914,000.

Page 13: Table 13. Distributions to Charity, Problem Gambling, and Responsible Gaming

British Columbia: *Total Charity 2010-11* was \$134,900,000.

Quebec: *Total Charity 2010-11* was \$28,402,000. *Total Responsible Gaming 2010-11* was \$7,213,000.

Canada: *Total Charity 2010-11* was \$369,590,000. *Total Responsible Gaming 2010-11* was \$29,517,000.

Page 14: Figure 4. Percentage of Government Gaming Revenue Distributed to Problem Gambling

Quebec: 2010-11 figure was 1.65.

Prince Edward Island: 2010-11 figure should have been reported as unavailable.

Canada: 2010-11 average was 1.44%.

Page 20: Table 20. Helpline Calls and Counselling

British Columbia: *Total Helpline Calls 2010-11 was 5,932. Total FTE Counsellors 2010-11 was 30.*

Nova Scotia: *Total Clients 2010-11 was 249.*

Canada: *Total Helpline Calls 2010-11 was 31,395; Total FTE Counsellors 2010-11 was 188; Total Clients 2010-11 was 249.*

Page 21: Table 21. On-site Information and Support at Gaming Venues

British Columbia: *Total Breaches Detected was 8,008.*

Canada: *Total SE Breaches 2010-11 was 16,860.*
